

PA Criminal Record Check – Act 34

You can obtain the PA Criminal Record check in <u>one</u> of the following two ways:

1. Order the record check on-line by logging onto <u>https://epatch.pa.gov/home</u> and select "Submit a New Record Check". You must provide your name and address, individual information and credit card information.

If a request goes "under review" it will be updated to the status of "No Record" or "Record" within two weeks.

For all "No Record" responses, the certificate must be printed out at the requestor's computer.

Please be sure to print a copy of the certificate form with the logo in the background (you must click on the link called "Certificate Form"); otherwise it is not considered official and will not be accepted as a current clearance.

OR

Fill out Part I of the Pennsylvania State Police Request for Criminal Record Check Form SP -164 (attached). The form should be submitted with a money order in the amount of \$22.00 payable to *Commonwealth of Pennsylvania*. After completion mail to:
